

HERTZ CAR SALES – ‘SO GOOD IT HERTZ’ PROMOTION

Terms and Conditions

1. The Promoter is Australian Radio Network ACN 065 986 987, 3 Byfield Street, North Ryde, New South Wales, 2113.
2. The Radio Stations are Mix106.5, Mix101.1 Mix102.3, 97.3Fm, WSFM, Gold104.3 and 4KQ.
3. Information on how to enter and prizes form part of these terms and conditions. Any general competition rules or terms and conditions of the Radio Station do not apply to this Promotion.
4. Any entry which does not comply with these terms and conditions is invalid.
5. Entry is open to residents of Australia. Entrants under the age of 18 must have permission from their parent or legal guardian to enter the Promotion. Employees or contractors of the Promoter or its associated companies, employees or contractors of any agencies, affiliates, sponsors, sub-sponsors or representatives of the Promoter and the immediate families of any such employees or contractors are not eligible to enter. Any person who has won one or more prizes valued individually or collectively at more than \$100 from the Promoter or the Radio Stations in any promotion within the past 30 days is ineligible to enter.

The car will be redeemed and collected from the Hertz Car Sales location within the winner’s state.
